That the following Propositions or questions were passed or defeated as indicated:

BUTMAN TOWNSHIP – ROAD MILLAGE PROPOSAL

Shall the Township of Butman, Gladwin County, Michigan, increase the limitation on the total amount of general ad valorem taxes which may be imposed for all purposes upon real and personal property in the Township, as provided in Article 9, Section 6, of the Michigan Constitution of 1963, as amended, by one and one-half (1.5) mill (\$1.50 per \$1,000.00) of taxable valuation as finally equalized, for a period of five (5) years (2011 through 2015, inclusive), which levy would provide estimated revenues to the Township of \$210,000.00 in its first year if approved and levied, for the purpose of maintenance and improvement of roads within the Township?

Shall the tax limitation on general ad valorem taxes within Gladwin County, imposed under Article IX, Sec. 6 of the Michigan Constitution be a continuation for said County by up to .75 mills (\$.75 per \$1,000 of taxable value) for the period of 2012 thru 2016 commencing with the 2012 tax billing inclusive for the purpose of providing operational funding for the County Emergency 911 Dispatch program; and shall the County levy such millage for said purpose, thereby, raising in the first year an estimated \$703,319.00?
