
State Proposal 14-1

Approval or Disapproval of Amendatory Act to Reduce State Use Tax and Replace with a Local Community Stabilization Share to modernize the Tax System to Help Small Businesses Grow and Create Jobs

The amendatory act adopted by the Legislature would:

- 1. Reduce the state use tax and replace with a local community stabilization share of the tax for the purpose of modernizing the tax system to help small businesses grow and create jobs in Michigan.
- 2. Require Local Community Stabilization Authority to provide revenue to local governments dedicated for local purposes, including police safety, fire protection, and ambulance emergency services.
- 3. Increase portion of state use tax dedicated for aid to local school districts.
- 4. Prohibit Authority from increasing taxes.
- 5. Prohibit total use tax rate from exceeding existing constitutional 6% limitation.




PINCONNING AREA SCHOOLS




