CERTIFICATE OF DETERMINATION

The Board of Canvassers of the County of Gladwin having ascertained and canvassed the votes of said Regular Election, held on the 8th day of November, 2016.

DO HEREBY CERTIFY AND DETERMINE

That the following Propositions or questions were passed or defeated as indicated:

Emergency Medical Services

For the purpose of continuing the provision of Emergency Medical Services (EMS) in Gladwin County, for four (4) years (being 2018 to 2021 inclusive) shall the County of Gladwin levy up to 1 mill (\$1.00 per \$1,000 of taxable value), commencing with the December 2017 tax billing through the 2020 tax billings, such assessment begin an increase over the 15 mill limitation provided in Section 6, Article IX of the Michigan Constitution of 1963.

This tax will renew and continue a tax which otherwise expires in the 2016, and would raise up to an estimated \$940,355 in the first calendar year, based upon taxable value.

Note: A portion of the millage monies raised in their respective jurisdictions may be disbursed to the Downtown Development Authority of the City of Gladwin and Beaverton pursuant to the state law.

Shall the tax limitation of general ad valorem taxes within Gladwin County, imposed under Article IX, Section 6 of the Michigan Constitution be a continuation for said County by up to .75 mils (\$.75 per \$1,000 of taxable value) for the period of 2017 thru 2022 commencing with the 2017 tax billing inclusive for the purpose of providing operational funding for the County Emergency 911 Dispatch program; and shall the County levy such millage for said purpose, thereby, raising in the first year an estimated \$705,266.00.




