### Commissioner Minutes of August 27, 2019

The Gladwin County Board of Commissioners met in Regular Session on Tuesday, August 27, 2019. The meeting was called to order at 9:00 a.m. by Chairperson Smith. The Pledge of Allegiance was recited and a short prayer was given. Roll call found all Commissioners present.

The Board reviewed the agenda. Motion by Commissioner Vernier, supported by Commissioner Taylor, to proceed with the consent agenda as prepared. Ayes carried, motion passed.

The **cash balances** were then read by Commissioner Taylor. General Fund—
S99,577.48. An advance of \$750,000 has been made to the General Fund from the 210—
EMS Fund.

The Regular Session minutes of August 13, 2019, along with the Committee of the Whole Executive Session minutes of the same date, were then reviewed. Commissioner Rick Grove expressed his concern over action taken during this meeting and would ask the Board for a motion to reconsider the Leadership action taken during this session. Motion supported by Commissioner Taylor. Ayes carried, motion passed. Discussion was held on the following topics: 1) Need for a policy that addresses the use of county hours for volunteering. 2) That for now, these requests will be taken on a "case by case" basis. 3) The benefit of the Leadership Program in Gladwin County. 4) Various other venues that could be considered "volunteering". Chairperson Smith noted that the personnel policy needs reviewed and updated with appropriate research done as to the proper wording for this topic. Motion by Commissioner Vernier, supported by Commissioner Kyle Grove, to approve the minutes as prepared. Ayes carried, motion passed.

**Public Comments** – none at this time.

#### Communications:

- A thank you letter received by the Health Department regarding the paving project.
- That a letter has been sent to the Insurance Committee.
- On the letter sent to the General Agency.
- On the signed letter that has been sent to the Leadership Board.

#### <u>Finance Matters – Commissioner Taylor:</u>

- Bob North, Emergency Management Director, presented quotes needed for the replacement of AED batteries and supplies. Allied 100 - \$1,286.89, American AED - \$1,762.90 and Cardiac Partners - \$1,549.72. Motion by Commissioner Taylor, supported by Commissioner Rick Grove, to allow Mr. North to place the order with Allied 100 in the amount of \$1,286.89 from 101-426-727.000. Ayes carried, motion passed.
- 2. Mr. North also requested the purchase of two cameras in the amount of \$459.88 from 101-426-727.000. These cameras will replace the broken cameras and allow him to prepare the EHP for the State of Michigan. Motion by Commissioner Taylor, supported by Commissioner Vernier, to allow for the purchase as outlined. Ayes carried, motion passed.
- 3. Dylan DeBoever, Maintenance, has resigned his position with the County of Gladwin effective August 23, 2019. Mr. DeBoever is eligible for payout of 28 unused vacation hours per his union contract in the amount of \$480.76 from 101-265-703.000. Mr. DeBoever has requested to donate the balance of his sick time in lieu of payment as follows: Krystal Govitz – 30 hours and Lindsie

- Dillon 34.5 hours. Motion by Commissioner Taylor, supported by Commissioner Vernier, to allow for the disbursement and donation of time as outlined. Ayes carried, motion passed.
- 4. Ken Roberts, Veteran Affairs, presented the Veterans Committee with three quotes for an "event trailer" that will be purchased for his department. Commissioner Taylor explained the benefits of having the trailer to provide services during fairs and other events and read the three quotes as follows: Loose \$8,000.00, US 27 \$8,700.00 and Beck's \$15,000.00. The total cost of this project is to be funded through the State Veterans' Service Fund Grant which is only available through September 30, 2019. Motion by Commissioner Taylor, supported by Commissioner Rick Grove, to allow Mr. Roberts to award the quote to Loose with a payment to be promptly handled for the ordering of materials. Ayes carried, motion passed.

#### **Committee Meetings:**

Motion by Commissioner Taylor, supported by Chairperson Smith, to accept and file the various minutes as presented. Ayes carried, motion passed.

#### Miscellaneous:

Chairperson Smith noted discussion at the Council of Local Government meeting last night on the state law prohibiting the cutting of "M Roads" more than once a year under Act 51.

#### **New Business:**

- Tristan Hewitt, Gypsy Moth Administrator, came before the Board with a proposal to prepare a limited scope study of the egg masses in Gladwin County for 2019. Mr. Hewitt explained the funding limitations in the Gypsy Moth fund, hoping this approach will not exceed the \$6,288.41 balance that remains. Discussion. Motion by Commissioner Taylor, supported by Commissioner Kyle Grove, to approve the count process in the heavily identified areas from the 2018 study. Ayes carried, motion passed. Mr. Hewitt stated he will be meeting with the committee on September 4, 2019 to review his request for additional funding until the millage money can be collected for his department.
- Commissioner Vernier presented the Proclamation in support of the Complete
  Count Committee that promotes the activities of the Gladwin County Census.
  Commissioner Vernier stated that the committee has already been pledged
  \$3,500.00 and will be eligible for state and federal funding with the passage of
  this proclamation. Motion by Commissioner Vernier, supported by Commissioner
  Taylor, to approve the Proclamation as drafted. Roll call vote as follows: Kyle
  Grove yes, Ronald Taylor yes, Joel Vernier yes, Sharron Smith yes, Rick
  Grove yes. Ayes carried, Proclamation 2019-022 declared adopted.
- Commissioner Vernier then presented a Resolution to Express Opposition to
  Termination of State Contract with the Lakeshore Regional Entity.
  Commissioner Vernier voiced his concern in taking local control away from the
  Mental Health Services. Motion by Commissioner Vernier, supported by
  Commissioner Taylor, to adopt the resolution as presented. Roll call vote as
  follows: Ronald Taylor yes, Joel Vernier yes, Sharron Smith yes, Rick
  Grove yes, Kyle Grove -yes. Ayes carried, Resolution 2019-023 declared
  adopted.
- Motion by Commissioner Taylor, supported by Commissioner Kyle Grove, to allow Attorney Amtsbuechler with MMRMA to proceed with the settlement parameters given during the executive session of August 21, 2019. Ayes carried, motion passed.

# Gloduin COUNTY BOARD OF COMMISSIONERS RESOLUTION 2019-023

# RESOLUTION TO EXPRESS OPPOSITION TO TERMINATION OF STATE CONTRACT WITH THE LAKESHORE REGIONAL ENTITY

WHEREAS, on June 28th the Michigan Department of Health and Human Services (MDHHS) notified the Lakeshore Regional Entity (LRE), its member Community Mental Health organizations, and the general public regarding: its intent to terminate the specialty Prepaid Inpatient Health Plan contract with the LRE effective September 30, 2019; and

WHEREAS, this proposal, by the Michigan Department of Health and Human. Services (MDHHS), causes a great deal of unnecessary chaos and conflict for the over 250,000 Medicaid recipients within the seven counties in Lakeshore Regional Entity; and

WHEREAS, this proposal eliminates local public governance of the public behavioral health system-one of the foundations of Michigan's nationally recognized behavioral health system for the past 50 years - and replaces it with a state-appointed advisory group; and

WHEREAS, this proposal does not get to the root cause of the fiscal distress of Lakeshore Regional Entity nor of the other Prepaid Inpatient Health Plans (PIHPs) facing such distress - inadequate funding over a sustained period. Without adequate funding, as required by the Michigan Mental Health Code and Michigan's Medicaid Plan, the Lakeshore system and others who have been underfunded - regardless of the greater involvement of the state in the operation of the local public system - will be unable to pay providers and provide behavioral healthcare services to persons entitled to such services; and

WHEREAS, a better plan could be achieved sooner, simpler, and more directly without eliminating the local public control of the public behavioral healthcare system in this region. This plan would include, MDHHS joining Lakeshore and Beacon Health Options a three-way contract co-managing the benefit in the region; and

WHEREAS, a three-way contract maintains the momentum already achieved by the Lakeshore/Beacon partnership; maintains the local public governance of the public behavioral health system; and prevents the unnecessary chaos that the MDHHS proposal would create; and

NOW THEREFORE BE IT RESOLVED, that the County of <u>Gracies</u> requests that the Michigan Department of Health and Human Services (MDHHS) do not terminate its contract with the Lakeshore Regional Entity, thereby ensuring respect for the law and the rich history of Michigan's mental health system, which is clear in its intent to maintain a publicly governed mental health system.

BE IT FURTHER RESOLVED that copies of this resolution be provided to Governor Gretchen Whitmer, Senator Jim Stamas, Representative Jason Wentworth, Michigan Department of Health and Human Services Director Robert Gordon, Behavioral Health and Developmental Disabilities Administration Deputy Director Dr. George Mellos, and the Michigan Association of Counties.
