The Gladwin County Board of Commissioners met in Regular Session on Tuesday, August 11, 2020. The meeting was called to order at 9:00 a.m. by Chairperson Smith. The Pledge of Allegiance was recited. Roll call found all Commissioners present.

The Board reviewed the agenda. Motion by Commissioner Vernier, supported by Commissioner Kyle Grove, to proceed with the consent agenda as prepared. Ayes carried, motion passed.

The cash balances were read by Commissioner Taylor. General Fund - \$150,534.43.

The regular minutes of July 28, 2020 were then reviewed. Motion by Commissioner Vernier, supported by Commissioner Kyle Grove, to approve the minutes as drafted. Ayes carried, motion passed.

#### **New Business:**

- 1. The Board reviewed the current COVID policy. Discussion. Motion by Commissioner Vernier, supported by Commissioner Kyle Grove, to extend the policy for an additional 60 days unless there is a directive from the Governor. Ayes carried, motion passed.
- 2. A Proclamation has been drafted to declare September 17-23, 2020 as Constitution Week and was read by Chairperson Smith. Motion by Commissioner Smith, supported by Commissioner Taylor, to adopt the proclamation as read. Roll call vote as follows: Commissioner Kyle Grove yes, Commissioner Ronald Taylor yes, Commissioner Joel Vernier yes,

- Commissioner Sharron Smith yes, Commissioner Rick Grove -yes. 5 yes, 0 no. Ayes carried, Proclamation 2020-013 declared adopted.
- 3. A Resolution in support of the Buckeye Rail Trail Grant has been drafted for approval. Discussion on the matching funds of \$89,700 that are noted within the document. It was clarified that funds are being raised and held with the City of Gladwin for this purpose and that Gladwin County has no direct financial obligation toward this project. Motion by Commissioner Vernier, supported by Commissioner Taylor, to adopt the Resolution as drafted with the understanding that the County will not be contributing financially. Roll call vote as follows: Commissioner Ron Taylor yes, Commissioner Joel Vernier yes, Commissioner Sharron Smith yes, Commissioner Rick Grove yes, Commissioner Kyle Grove yes. 5 yes, 0 no. Ayes carried, Resolution 2020-014 declared adopted.
- 4. The Board reviewed an RFP that has been drafted for the installation and repairs of a roof on the Courthouse. The Clerk will publish this RFP in the local paper with the return date for sealed bids as September 2, 2020. Motion by Commissioner Taylor, supported by Commissioner Rick Grove, to approve the RFP to be published as reviewed. Ayes carried, motion passed.
- 5. An RFP has also been drafted for County Attorney Services. The Clerk has been directed to publish this in the local paper with a return date for sealed bids as September 2, 2020. Motion by Commissioner Rick Grove, supported by Commissioner Taylor, to approve the RFP for publication. Ayes carried, motion passed.
- 6. The Service Agreement with CBIZ for actuarial services was reviewed. Motion by Commissioner Taylor, supported by Commissioner Kyle Grove, to allow the Chairperson to sign the agreement as prepared. Ayes carried, motion passed.
- 7. The Gladwin County Planning Commission has reviewed a request to change a section in Beaverton Township from Business One to Residential Farming. It is the request of the Planning Commission to have the Board support their decision to approve the rezoning as outlined. Commissioner Kyle Grove spoke on the Planning Commission's process in reviewing these requests and feels comfortable with the recommendation. Motion by Commissioner Kyle Grove, supported by Commissioner Rick Grove, to approve the rezoning request as recommended by the Planning Commission. Ayes carried, motion passed.

#### Commissioner Kyle Grove reported:

• That he received an email from the Dollar General representative on the parcel in Sherman Township inquiring if anything else could be done to get the project on track. Additional locations were given for their consideration.

- On attending the FEMA meeting on July 29th.
- That he met with MMRMA, Mike Rajt and Spicers Engineering at Chappel Dam on July 31<sup>st</sup> to review the potential loss and damage due to the flood.

- On the Gladwin City meeting on August 3<sup>rd</sup> at the Airport pavilion. Mike Hargrave, Airport Manager, showed the committee some of the new equipment that has been purchased.
- That he attended the FEMA meeting on August 5<sup>th</sup>.
- On the Committee of the Whole meeting on August 5<sup>th</sup>.
- That he participated in the Sage Township Lake Improvement meeting on August 6<sup>th</sup>, noting discussion on the five-year plan for weed control.
- On the Veterans meeting where the trust fund grant was discussed. Due to Covid, the State is considering allowing the County to roll some of the grant funding into 2021 for use.

3. To construct the project and provide such funds, services, and materials as may necessary to satisfy the terms of said Agreement.
4. To regulate the use of the facility constructed and reserved under this Agreement to assure the use thereof by the public on equal and reasonable terms.
5. To comply with any and all terms of said Agreement including all terms not specifically set forth in the foregoing portions of this Resolution."
