  - 1. Undersheriff Hartwell is requesting Board Approval to purchase a desktop computer for Sergeant Townsend, who was assigned to the Department of Justice Grant. This is 100% paid for by grant funding and will be vouchered from 101-301-933.00 for payment. The two quotes were \$899.99 from Genesis Computer System and \$780.00 from I.T. RIGHT.
  - 2. Prosecutor Attorney's office needs to purchase "conversion parts" for the Polycom system in District Courtroom for an upcoming Jury Trial. A motion is needed to allow the Clerk to make the purchase from Amazon, at the recommendation of I.T. RIGHT, using the credit card. The parts are not exceeding \$50.00 and will be paid from 101-229-933-000.
