
Has failed to inform the public with details of the costs of the sewer project.

On or about 08/01/07, Linda Frye made unauthorized purchases totaling over \$2500.00, including a Staples gift card, using township funds.


JUSTIFICATION OF CONDUCT IN OFFICE OF LINDA FRYE:



Secord Township Road Millage

Shall the 15 mill tax limitation on general Ad Valorem taxes within Secord Township, Gladwin County, be increased by 3.00 mill (\$3.00 per \$1,000 of taxable value) on taxable value of real and personal property for a period of 5 years, 2008-2012 inclusive, and said millage to be used exclusively for road construction (2.25 mills) and road maintenance (0.75 mills)? This is a renewal of 2.00 mill formerly approved by the voters for road construction and expired in 2007, and 1.00 mill formerly approved by the voters for road maintenance and expired in 2007. If approved and levied the estimated amount of revenue for 2008 road construction would be \$208,236.12, and the estimated amount of revenue for 2008 road maintenance would be \$69,412.05.
