## Commissioner Minutes of November 26, 2019

The Gladwin County Board of Commissioners met in Regular Session on Tuesday, November 26, 2019. The meeting was called to order at 9:00 a.m. by Chairperson Smith. The Pledge of Allegiance was recited and a short prayer was given. Roll call found all Commissioners present. Commissioner Smith expressed her thanks to the Board members who filled in for her during her absence.

The Board reviewed the agenda. Motion by Commissioner Taylor, supported by Commissioner Kyle Grove, to proceed with the consent agenda as corrected. Ayes carried, motion passed.

The **cash balances** were then read by Commissioner Taylor. *General Fund – S224,033.95*.

The regular minutes of November 12, 2019 were then reviewed. Motion by Commissioner Vernier, supported by Commissioner Taylor, to approve the minutes as drafted. Ayes carried, motion passed.

<u>Public Comments</u> – none currently.

## Communications:

1. Library Usage Report - October 2019.

### Finance Matters - Commissioner Taylor:

- The Board previously approved a payment of \$200,000 as a down payment against the loan for the Courthouse renovations. This payment was to be supported by an appropriation from Unallocated. Motion by Commissioner Taylor, supported by Commissioner Rick Grove, to allow the Treasurer to allocate \$200,000 from Unallocated to cover the expense of the down payment. Ayes carried, motion passed.
- 2. The Prosecuting Attorney has requested the establishment of a revenue line for the collection of "costs of prosecution". Motion by Commissioner Taylor, supported by Commissioner Vernier, to allow the Treasurer to create line 101-000-525.000 for this purpose. Ayes carried, motion passed.
- 3. The following budget amendments need to be handled to ensure the proper disbursement of grant funding into the Veterans 297 fund:

297-000-571.000 \$37,000 297-000-727.000 \$600 297-000-727.001 \$50 297-000-727.002 \$22,700 297-000-860.000 \$1,000 297-000-933.000 \$12,650

Motion by Commissioner Taylor, supported by Commissioner Vernier, to allow the Treasurer to make the budget entries as listed. Ayes carried, motion passed.

- 4. Stacey DeMoines, Treasurer's Office, has requested payment for 70 hours of unused vacation time per her Unit #7 contract. Total payment of \$1,432.90 will be paid from 101-253-704.000 upon approval. Motion by Commissioner Taylor, supported by Commissioner Kyle Grove, to approve the Clerk to make the disbursement as outlined. Ayes carried, motion passed.
- 5. The payment of \$30,000 that has been scheduled as an additional contribution to the County's unfunded liability with MERS is ready for payment from 101-861-720.000. Motion by Commissioner Taylor, supported by Commissioner Kyle Grove, to allow the Clerk to make the additional disbursement to MERS as outlined. Ayes carried, motion passed.

- 2. Yvette Keast, Gladwin County Chamber of Commerce, presented the branding logo designs for Board approval. Motion by Commissioner Taylor, supported by Chairperson Smith, to approve "design A". Discussion on changes to include a deer in the logo. The motion was withdrawn and Ms. Keast will bring an updated logo to the Committee of the Whole meeting on December 4, 2019.
- 3. The Hillside Drive reconstruction project was discussed. A proposal has been drafted by the Road Commission to utilize the Wiggins Lake property to back fill excess dirt from the project. *Motion by Commissioner Taylor, supported by Commissioner Rick Grove, to approve the property use agreement as proposed.* Ayes carried, motion passed.
- 4. MSU has presented a contract for 2020 Extension Services. Motion by Commissioner Vernier, supported by Commissioner Rick Grove, to allow the Chairperson to sign the contract as drafted. Ayes carried, motion passed.
- 5. Attorney Hovey has drafted the documents for the sale of county property to Mr. Schwager. Review and discussion. Motion by Commissioner Rick Grove, supported by Commissioner Taylor, to allow the Chairperson to sign the necessary agreements to authorize the sale of the property to Mr. Schwager by resolution and Quit Claim Deed. Roll call vote as follows: Kyle Grove yes, Ronald Taylor yes, Joel Vernier yes, Sharron Smith yes, Rick Grove yes. 5 yes, 0 no. Ayes carried, Resolution 2019-027 declared adopted.
