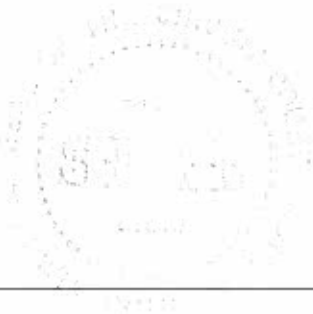

**CANVASS OF VOTES CAST AT THE

Held on Tuesday, August 2022, Gladwin County, Michigan, and canvassed by the Board of County Canvassers of Gladwin County, Michigan.

**STATEMENT OF VOTES**

The statements of votes polled on Tuesday, August 2, 2022, and filed with the County Clerk, and this Board, having duly examined and considered the statements, do hereby show the whole number of votes given for and against candidates and propositions, reading as follows:

**GLADWIN COUNTY EMERGENCY 911 DISPATCH SYSTEM**

Shall the limitation on ad valorem taxes within Gladwin County, imposed under Article IX, Section 6 of the Michigan Constitution, be increased to a total of up to 1 mill ((\$1.00 per \$1,000.00 of taxable value) for the period beginning December 2022, through December 31, 2027, inclusive. This is an increase of \$0.25 mil to the current millage ending December 31, 2022, and would raise an estimated revenue of \$1,104,295.18 in the first year, to be used for the purposes of providing emergency 911 dispatch services as authorized by law.

**GLADWIN COUNTY ANIMAL CONTROL**

Shall the limitation on ad valorem taxes within Gladwin County, imposed under Article IX, Section 6 of the Michigan Constitution, be renewed at \$0.20 mill (\$0.20 per \$1,000.00 of taxable value) for the period of 2023 through 2027 inclusive, beginning with the December 2022 tax billing cycle. This is a renewal of the current millage and would raise an estimated revenue of \$259,994 in the first year, to be used for the purposes of providing Animal Control services as authorized by law. If approved and levied in accordance with State law, a portion of the millage monies raised in their respective jurisdictions may also be captured by the Downtown Development Authority of the Cities of Beaverton and Gladwin.

### BEAVERTON TOWNSHIP MILLAGE

Shall the previously voted increase in the tax limitation imposed under Section 6, Article 9, of the Michigan Constitution, on general ad valorem taxes within the Township of Beaverton, State of Michigan, be renewed at 1.98 mills (\$1.98 per \$1,000 of taxable value) for a period of 5 years commencing on 2023 through 2027 inclusive for the purpose of constructing and improving local roads; and shall the Township levy such renewal in millage for said purpose, thereby, raising in the first year an estimated \$108,598.54 commencing with the December 2023 tax billing.

### GLADWIN COUNTY EMERGENCY MEDICAL SERVICES

For the purpose of continuing to provide emergency medical services in Gladwin County, for four (4) years (being 2023 to 2026 inclusive) shall the County of Gladwin levy up to 1 mill (\$1.00 per \$1,000 of taxable value), commencing with the December 2022 tax billing through the 2025 tax billing; such assessment being an increase over the 15 mill limitation provided in Section 6, Article IX of the Michigan Constitution of 1963. This tax will renew and continue a tax which was previously levied at .9958 mills which otherwise expired December 2020 and would raise an estimated \$1,299,970 in the first calendar year, based upon the 2022 taxable value. If approved and levied in accordance with State law, a portion of the millage monies raised in their respective jurisdictions may also be captured by the Downtown Development Authority of the Cities of Beaverton and Gladwin.

Shall Hay Township continue a 3/4 mill (\$0.75 per 1,000 of taxable value) in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution, to provide road maintenance, and levy it for 5 years, 2023 through 2027 inclusive, to raise an estimated \$40,411.34 each year the millage is levied.

Shall the limitation on the total amount of taxes which may be assessed each year against all property subject to taxation in Tobacco Township, Gladwin County, Michigan be increased by 1 mil (\$1 per \$1,000.00 of equalized taxable value) to provide mosquito abatement for a period of 10 years from 2022 through 2031 (this one mill increase will raise an estimated \$108,647 for the first year the millage is levied) as provided by Section 6, Article 1X of the Constitution of the state of Michigan.
