

**COUNTY OF GLADWIN**  
**RESOLUTION TO APPROVE BALLOT PROPOSAL**  
**EMERGENCY MEDICAL SERVICES**  
**2022 AUGUST PRIMARY ELECTION**

THE BOARD OF COMMISSIONERS, OF COUNTY OF GLADWIN, STATE OF MICHIGAN, STATES:

WHEREAS, the Board of Commissioners for the County of Gladwin do agree to place a millage proposal on the ballot for the citizens of the County of Gladwin to vote on whether or not they would be in favor of levying a millage to provide certain funding for Gladwin County Emergency Medical Services, as authorized by law; and

WHEREAS, this millage proposal is a general millage; and

WHEREAS, the Board of Commissioners of the County of Gladwin do agree to request a renewal of 1 mill from 2023 through 2026 inclusive, beginning with the December 2022 tax billing cycle to be used for the purposes of providing Emergency Medical Services as authorized by law; and

WHEREAS, the Board of Commissioners of the County of Gladwin has agreed to request that the Gladwin County Election Commission approve the millage proposal being placed on the ballot for the 2022 Primary Election to be held on August 2, 2022.

NOW THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF GLADWIN, HEREBY RESOLVES AS FOLLOWS:

RESOLVED, that the Gladwin County Emergency Medical Services Proposal, the language for which is attached hereto, be placed on the Election ballot to be voted upon by the electors in the County of Gladwin on Tuesday, August 2, 2022; and it was further

RESOLVED, that a copy of this Resolution and Ballot Proposal be submitted to the Gladwin County Clerk for placement on the ballot; and it was further

RESOLVED, that the Clerk of the County of Gladwin shall perform any and all things or matters as may be necessary or appropriate under the law to place the above proposition on the ballot as specified.

## BALLOT QUESTION

### GLADWIN COUNTY EMERGENCY MEDICAL SERVICES

#### BALLOT WORDING

Shall Gladwin County levy, for four (4) years (being 2023 to 2026 inclusive), up to 1 mill (\$1.00 per \$1,000/taxable value), for emergency medical services, commencing with the December 2022 tax billing through 2025 tax billing; such assessment being an increase over the 15 mill limitation provided in Section 6, Article IX of the Michigan Constitution of 1963. This tax will renew a tax that was levied at .9958 mills expiring December 2020 and would raise an estimated \$1,104,295.18 in the first calendar year, based upon the 2022 taxable value. If levied, a portion may be captured by Tax Increment Financing Authorities.
