## Miscellaneous

- 1. Request of a Resolution for Michigan Institute of Forensic Science and Medicine (MISFM)
  - A motion was made by Commissioner Taylor to adopt a resolution to appoint Dr. Roshan Mahibar, MD, PhD, MPH as Chief Medical Examiner for Gladwin County and Dr. Donald Higgs, MD, PhD as Chief Deputy Medical Examiner for Gladwin County; seconded by Commissioner Visnaw. Additional conversation was had on the timing of this request. Roll call vote, 5 Y, 0 N, resolution adopted.
- 2. Gladwin Community Schools Update
  - Gladwin School Superintendent, Rick Seebeck, shared information on the condition of the current junior high school building, the cost of repairing the infrastructure, and the purpose behind the maillage they

are seeking this year. Additional information was share on what the new building would look like, and the plans for the current building if the maillage passes.

#### **New Business**

- 1. Gladwin County Broadband Initiative Update -
  - MI Works Director, Matt Lang; Scott Govitz, and Ryan Peel from Point Broadband were present to share information with the board. Mr. Govitz shared some of the history of the broadband project. Mr. Lang discussed the lack of Broadband in Gladwin County and the Robin Grant Program. Chair Moore shared the counties involvement in the project so far. Mr. Peel gave an overview of Point Broadband, the unserved /underserved population in our area and the plan for serving Gladwin County. They are seeking a resolution or letter of support from the county. Commissioner Taylor motioned to approve a resolution in support of Point Broadband's grant application, seconded by Commissioner Visnaw. Roll call vote will be done when the physical resolution is available for reading later in the meeting.
- Part-time Staff for Court House Security
   Commissioner Moore shared information that had been presented at the Personnel Committee meeting
   this morning, the possibility of having MIDC grant coverage for this position, and the recommendation
   of the committee to allow the Undersheriff to hire.
  - A motion was made by Commissioner Moore, seconded by Commissioner Taylor, to allow the hiring of a part-time security officer at \$17.98 per hour, for 20 hour works a week. Additional input was given from Commissioner Taylor on the committee conversation. All in favor, motion carried.
