**RESOLUTION TO APPONIT MEMBERS TO THE JOINT WEST BRANCH
COMMUNITY AIRPORT ZONING BOARD**

RESOLUTION 2023-016

WHEREAS, on December 5, 1969 the Joint West Branch Community Airport Zoning Ordinance was created by the Board of Supervisors of Ogemaw County, Arenac County, Gladwin County and the Michigan Aeronautics Commission as allowed under the Airport Zoning Act, Act 23 of 1950, being MCL 259.431 et seq; and

WHEREAS, an "airport hazard area" was identified, as provided in the Act, upon which an airport hazard might be established if not prevented; and

WHEREAS, the purpose of the Ordinance is to establish regulations to restrict the height of structures and objects of natural growth and otherwise regulate the use of property in the hazard area; provide for the allowance of variances from such regulations; designate the administrative agency charged with administration and enforcement of such regulations; establish an airport zoning board of appeals; and to provide for enforcement and imposition of penalties for Ordinance violations; and

WHEREAS, the Joint Board charged the Ogemaw County Zoning Commission with responsibility of administration and enforcement of the Ordinance in close cooperation with the other participating entities; and

WHEREAS, the terms of office for all Gladwin County representatives on the joint airport zoning board have expired; and

WHEREAS, the board of commissioners of each county involved must appoint three members to the joint airport zoning board (MCL 259.447); and

WHEREAS, the Planning and Zoning Administrator successfully recruited three Gladwin County persons to serve on the joint airport zoning board.

THEREFORE, BE IT RESOLVED that the Gladwin County Board of Commissioners does hereby appoint Dale Taylor from Bourette Township, Michael Visnaw from Butman Township, and Eric Hose from Clement Township to the Joint West Branch Community Airport Zoning Board, representing townships within which the established hazard area, for terms to expire on December 31, 2025.
