RESOLUTION TO APPROVE BALLOT PROPOSAL
COUNTY ROAD AND BRIDGE MILLAGE RENEWAL
2023 SPECIAL ELECTION
Resolution # 2023-017

THE BOARD OF COMMISSIONERS, OF COUNTY OF GLADWIN, STATE OF MICHIGAN, STATES:

WHEREAS, the Board of Commissioners for the County of Gladwin do agree to place a millage proposal on the ballot for the citizens of the County of Gladwin to vote on whether or not they would be in favor of levying a millage to provide certain funding for the Gladwin County Road and Bridge construction and maintenance, as authorized by law; and

WHEREAS, this millage proposal is a general millage; and

WHEREAS, the Board of Commissioners of the County of Gladwin do agree to request a renewal of one point nine nine one six (1.9916) mills for six (6) years, to be collected annually in 2024 through 2029, inclusive, to provide certain funding to be used for the purposes of road and bridge construction and maintenance, and

WHEREAS, the Board of Commissioners of the County of Gladwin has agreed to request that the Gladwin County Election Commission approve the millage proposal being placed on the ballot for the 2023 Election to be held on August 8, 2023.

NOW THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF GLADWIN, HEREBY RESOLVES AS FOLLOWS:

RESOLVED, that the County Road & Bridge Millage Renewal Proposal, the language for which is attached hereto, be placed on the Election ballot to be voted upon by the electors in the County of Gladwin on Tuesday, August 8, 2023; and it was further

RESOLVED, that a copy of this Resolution and Ballot Proposal be submitted to the Gladwin County Clerk for placement on the ballot; and it was further

RESOLVED, that the Clerk of the County of Gladwin shall perform any and all things or matters as may be necessary or appropriate under the law to place the above proposition on the ballot as specified.

COUNTY ROAD AND BRIDGE MILLAGE RENEWAL
BALLOT QUESTION

Shall Gladwin County continue to levy 1.9916 mills (1.9916 per \$1,000.00 of taxable value, originally two (2) mills, subject to Headlee Amendment Reduction) on property located in Gladwin County for a period of six (6) years, a renewal millage. This millage would be levied beginning with the 2024 tax year, through 2029 tax levy year (inclusive), which will raise in the first year an estimated \$2,392,272, to be used for the purposes of improvements and construction of roads & bridges within Gladwin County. This levy would be collected on the winter tax bill of 2024, and thereafter. A portion of these revenues may be captured by any applicable Tax Increment Financing Authority constituted under the law.
