Dunbar Gladwin \$574.78. 197 proceedings assessing \$3,500.00. Motion to receive and file by Terry Walters. Seconded by Joe Sova. All in favor. Motion carried. Coolidge Gladwin \$1,840.88. 197 proceedings, assessing \$1,500.00. Motion to receive and file by Joe Sova. Seconded by Terry Walters. All in favor. Motion carried.

Governance for Coolidge 81% Gladwin and 19% Midland. FIOA and treasurer duties with the preauthorized amount of \$2,000.00 for maintenance motioned by Terry Walters. Seconded by Joe Sova. Roll Call vote. Motion carried.
