Item #2 Residential Heating System: This item is used for the installation of a heating system in a new residential structure. Item #11 – Gas piping and #25 – Duct **SHOULD NOT BE CHARGED**. Replacement systems should be itemized.

Items #16 & #18, Tanks: A homeowner must own tank to install, if not, a licensed mechanical contractor must install tank

VII Instructions for Completing Application

General: Mechanical work shall not be started until the application for permit has been filed with the Gladwin County Construction Codes Department. All installations shall be in conformance with the Michigan Mechanical Code. **No work shall be concealed until it has been inspected.** When ready for an inspection, call the office number provided on the permit with as much advance notice as possible. Please have the property owner's name and township when scheduling.

Expiration of Permit: A permit remains valid if work is progressing, and inspections are requested and conducted. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS HAVE BEEN DONE ONE (1) YEAR AFTER OBTAINING THE PERMIT OR IF NO INSPECTIONS HAVE BEEN DONE AFTER SIX (6) MONTHS OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
