### **RESOLUTION# 2023-018**

#### **TO APPROVE BALLOT LANGUAGE FOR A LAW ENFORCEMENT – PUBLIC SAFETY MILLAGE PROPOSAL at the August 2023 Election**

THE BOARD OF COMMISSIONERS, OF COUNTY OF GLADWIN, STATE OF MICHIGAN, STATES:

WHEREAS, the Board of Commissioners for the County of Gladwin do agree to place a millage proposal on the ballot for the citizens of the County of Gladwin to vote on whether or not they would be in favor of levying a millage to provide funding for law enforcement services, as authorized by law; and

WHEREAS, this millage proposal is a general millage; and

WHEREAS, the Board of Commissioners of the County of Gladwin do agree to request a new tax, of 1 ½ mills, (\$1.50 per \$1,000 of taxable value) for six (6) years, to be collected annually in 2023 through 2028, inclusive, to provide certain funding to be used for the purposes of funding Gladwin County Sheriff's Department law enforcement services.

WHEREAS, the Board of Commissioners of the County of Gladwin has agreed to request that the Gladwin County Election Commission approve the millage proposal being placed on the ballot for the 2023 Election to be held on August 08, 2023.

#### **Resolution**

NOW THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF GLADWIN, HEREBY RESOLVES AS FOLLOWS:

RESOLVED, that the Law Enforcement – Public Safety Millage Proposal, the language for which is attached hereto, be placed on the Election ballot to be voted upon by the electors in the County of Gladwin on Tuesday, August 08, 2023; and it was further

RESOLVED that a copy of this Resolution and Ballot Proposal be submitted to the Gladwin County Clerk for placement on the ballot; and it was further

RESOLVED, that the Clerk of the County of Gladwin shall perform any and all things or matters as may be necessary or appropriate under the law to place the above proposition on the ballot as specified.
