RESOLUTION TO APPROVE BALLOT PROPOSAL
SPONGY MOTH SUPPRESSION MILLAGE RENEWAL
2024 PRESIDENTIAL PRIMARY ELECTION

THE BOARD OF COMMISSIONERS, OF COUNTY OF GLADWIN, STATE OF MICHIGAN, STATES:

WHEREAS, the Board of Commissioners for the County of Gladwin do agree to place a millage proposal on the ballot for the citizens of the County of Gladwin to vote on whether or not they would be in favor of levying a millage to provide certain funding for the Gladwin Spongy Moth Suppression Program, as authorized by law; and

WHEREAS, this millage proposal is a general millage; and

WHEREAS, the Board of Commissioners of the County of Gladwin do agree to request a renewal of three quarters of one mill, (.75) for three (3) years, to be collected annually in 2024 through 2026, inclusive, to provide certain funding to be used for the purposes the Gladwin County Spongy Moth Suppression Program.

WHEREAS, the Board of Commissioners of the County of Gladwin has agreed to request that the Gladwin County Election Commission approve the millage proposal being placed on the ballot for the 2024 Presidential Primary Election.

NOW THEREFORE, THE BOARD OF COMMISSIONERS OF THE COUNTY OF GLADWIN, HEREBY RESOLVES AS FOLLOWS:

RESOLVED, that the Spongy Moth Suppression Millage Renewal Proposal, the language for which is attached hereto, be placed on the Election ballot to be voted upon by the electors in the County of Gladwin during the 2024 Presidential Primary Election; and it was further

RESOLVED, that a copy of this Resolution and Ballot Proposal be submitted to the Gladwin County Clerk for placement on the ballot; and it was further

RESOLVED, that the Clerk of the County of Gladwin shall perform any and all things or matters as may be necessary or appropriate under the law to place the above proposition on the ballot as specified.
