Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. Comments on the apportionment of benefits may be submitted to the Drain Commissioner in writing before the date of the day of review to the Gladwin County Drain Commissioner at 555 West Cedar Avenue, Gladwin, Michigan 48624 or to drains@gladwincounty-mi.gov, or comments may be submitted in writing or verbally at the day of review. Comments submitted in advance must be received by the Drain Commissioner prior to the day of review to ensure consideration.

The following is a list of any county, township, city, or village to be assessed: Gladwin County, Tobacco Township.

You may appeal the Drain Commissioner's decision to revise the district boundary to the Gladwin County Circuit Court within ten (10) days. You may appeal the Drain Commissioner's determination of apportionments to the Gladwin County Probate Court within ten (10) days.
