Finance

 Request Approval for the Purchase of Filing Cabinets for the Prosecutor's Office. Office Manager, Katie Newman, shared details of the request

A motion was made by Commissioner O'Donnell to approve the purchase of filling cabinets for the Prosecutors office. Total cost of three (3) cabinets at \$573.28 each, for a total of \$1,719.83, 100% to be paid from the Victim's Rights grant; line item 101-229-835-003. Seconded by Commissioner Taylor; all in favor, motion carried.

1. Request Approval for Region VII Area Agency on Aging Annual Implementation Plan for FY 2024 and Region VII Area Agency on Aging Report

Region VII Area Agency on Aging Executive Director, Bob Brown, and Board Director Joel Vernier, shared information on the Area Agencies on Aging including the programs they offer and their funding. Details of their Annual Implementation Plan were also shared. VA Director Ken Roberts shared that RVIIAAA programs also benefit local senior veterans.

A clean recommendation was issued by the Auditors, as well as a clean recommendation from the federal government regarding ARPA funds.
