GLADWIN COUNTY BOARD OF COMMISSIONERS
RESOLUTION NO. 2023-024

WHEREAS, the Wiggins Lake Level Authority Board (also referred to as the Wiggins Lake Authority), as the delegated authority designated by the Gladwin County Board of Commissioners (the “Board of Commissioners”) under Part 307 of the Natural Resources and Environmental Protection Act, Act 451 of 1994, as amended (“Part 307”), has the ongoing responsibility to maintain the court-ordered lake level of **Wiggins Lake**; and

WHEREAS, a special assessment district was established by the Gladwin County Circuit Court for **Wiggins Lake**, located in Sage Township, Gladwin County, Michigan under Part 307, specifically MCL 324.30704; and

WHEREAS, the Wiggins Lake Level Authority Board held a public hearing as the delegated authority for the Wiggins Lake - Lake Level Special Assessment District for Gladwin County on September 16, 2023 to review the computation of costs of a lake level control project, related to, among other things, general maintenance of the lake’s lake level control structure (the “Project”) and a special assessment roll consistent with the requirements of Part 307; and

WHEREAS, the Board of Commissioners has reviewed the computation of costs of the Project and the special assessment roll recommended for approval by the Wiggins Lake Level Authority Board.

NOW, THEREFORE, BE IT RESOLVED:

1. The Board of Commissioners approves the computation of costs of the Project and the special assessment roll as recommended by the Wiggins Lake Level Authority Board with the approval of assessments in the special assessment roll (five annual installments). MCL 324.30714(3). This approved roll expressly assesses Gladwin County at-large for 3% of the Project costs. See MCL 324.30711(1). The Board of Commissioners further authorizes annual expenditures that exceed \$10,000 annually for the Wiggins Lake – Lake Level consistent with the approved assessment roll and computation of costs for all years where annual assessment installments are collected. MCL 324.30722(4).
2. The special assessment roll with the assessments listed shall be final and conclusive unless appealed in a court within 15 days of the adoption of this resolution. MCL 324.30714(4).
3. The Gladwin County Clerk shall forward to the Wiggins Lake Level Authority Board a copy of this resolution so that action can be instituted by Gladwin County in an expedient manner.
4. All resolutions and parts of resolutions insofar as the same may be in conflict herewith are hereby rescinded.
