The Gladwin County Board of Commissioners met for a regular Board Meeting, on September 26, 2023. The meeting was called to order at 9:02 a.m. by Chairperson Karen Moore. The Pledge of Allegiance was said, all commissioners were present.

Public Comment - Agenda Items

The Board reviewed the consent agenda; Commissioner Moore asked to move new business item 1 to the beginning of the agenda before Finance, and to move Finance D to Finance A. A motion was made by Commissioner Taylor to accept the agenda with the changes, seconded by Commissioner Grove. All in favor, motion carried.

New Business

Assessment Roll for Wiggins Lake Level

Drain Commissioner Walters shared information on the proposed Dam Budget for 2024-2028 and lake levels at Wiggins Lake.

A motion was made by Commissioner Taylor and seconded by Commissioner O'Donnell, to approve the assessment roll and lake levels of Wiggins Lake.

A motion to adopt a resolution for Wiggins Lake Level Authority was made by Commissioner Taylor, and seconded by Commissioner O'Donnell. The resolution was read by Commissioner Moore, Roll Call vote, 5 - Y, 0 - N, resolution was adopted.

Finance

1. Equipment Purchase for Victim's Rights Grant.

A motion was made by Commissioner Taylor, seconded by Commissioner Grove, to approve the request made by the prosecutor's office to purchase equipment in the amount of \$1,153.98 from line 101-229-835.003; amount fully reimbursable through the Victims Right Grant. All in favor, motion carried.

3. Special Funds for FY2024 Budget

County Treasurer VanTiem shared information with the Board.

A motion was made by Commissioner Taylor to approve special funds for the FY24 budget, seconded by Commissioner Visnaw. All in favor, motion carried.

4. Everbridge Upgrades to the Nixle System.

Emergency Manager, Bob North shared details of expanded service options for Nixel. He is asking the board to approve upgrades to include these new services.

A motion was made by Commissioner Taylor to approve the payment of \$1,879.98 to Everbridge from line 101-426-802.000 for Nixel upgrades, seconded by Commissioner Visnaw. All in favor, motion carried.

5. Presentation of Yearly Foreclosure Report

Report of Civil Attorney

- The County is not getting proper service from the planner hired in July of 2021, to update the master plan. The attorney is asking permission to terminate the contract and file a lawsuit to compel the planner to reimburse funds paid for services not rendered.

Motion by Commissioner Moore, seconded by all other commissioners to allow the attorney to terminate the contract and file a lawsuit. All in favor, motion carried.

The Sherriff just signed the latest collections.

An Ordinance book being worked on is about 2/3 done.

Public Comment -

- Joel Vernier, Secord Township Supervisor, shared his views on the perception of residents on the proposed Law Enforcement Milage.

He has spoken on tree cutting at Smallwood Lake and helped initiate fund raisers for Smallwood.

The second annual chili cookoff at Lost Arrow will be held on Oct 7th.

- Commissioner Visnaw shared some thoughts on pending assessments and proposal language, and how residents perceive the information. He asked what is really going to happen in Gladwin County if we are not able to fund the county.
- Commissioner O'Donnell shared her thoughts on the connection between the County Budget and the Public Safety / Law Enforcement Millage.
