The Gladwin County Board of Commissioners met for a regular Board Meeting, on October 10, 2023. The meeting was called to order at 9:00 a.m. by Chairperson Karen Moore. The Pledge of Allegiance was said, roll was called, and all commissioners were present.

1. Chair Appointment of a County FOIA Coordinator

Chair Moore made a motion, seconded by Commissioner Taylor, to appoint the Clerk interim FOIA Coordinator. All in favor, motion carried.

### **New Business**

1. Four Lakes Task Force Update

Dave Kepler addressed the Board to share an update on FLTF. Information was shared on the Sanford Dam bid process and the unexpected increase in cost for all the dam projects since planning. Informational meetings are being held to share information on the anticipated assessment. Financing options are being looked into for mid-2024, as well as grant opportunities and conversations with legislatures. Anticipated construction and completion dates were shared, and Mr. Kepler addressed questions from the Board.

2. 2024 Board Calander & Resolution to Approve

Attorney Hoerauf shared information on the Board Calendar and separating it from the Board Rules. Discussion was had on the change from a calendar year to a fiscal year and the thought of eliminating the second regular board meeting of December.

A motion was made to adopt the 2024 calendar as presented with the amendment to remove the Dec 27th meeting, seconded by Commissioner O'Donnell. All in favor, motion carried.

A Resolution was read by Chairperson Moore, motion to approve resolution by Commissioner Taylor,

3. Purchasing and Procurement Policy

Chairperson Moore shared the idea of a new Purchase Policy and shared a draft she had worked on with input from other elected officials.

4. Executive Secretary /Administrative Assistant Job Description

Chairperson Moore shared a Job Description for an Executive Secretary / Administrative Assistant.

A motion was made by Commissioner Moore to post the job description immediately, seconded by Commissioner Visnaw. Additional Conversation on posting the job description with applications due back by November 3rd, Special Meeting to review on Friday November 10<sup>th</sup> at 2:00 p.m.and interviews during the Regular Board Meeting on the 14<sup>th</sup>. All in favor, motion carried.

### Old Business

1. Master Plan Review

Attorney Hoerauf shared the need for a county master plan, along with the zoning information previously provided, and the idea that the County is working backwards in the process. It is the advice of the attorney that the master plan is adopted first, and zoning ordinances subsequently adopted to reach the goal(s) set in the Master Plan.

A motion was made by Commissioner O'Donnell to approve the Master Plan proposal as proposed by Wade Trim, seconded by Commissioner Taylor. Additional conversation was had; all in favor, motion carried.

## **Chairperson Comments**

Chairperson Moore stated that if an outdated policy is noticed, to please let her know and she would draft an update for board conversation. She shared that on Oct 17, 2023, at the Ideal Theater in Clare, will be a free showing of the movie Four Good Days, and is open to the public.
