Christian wanted to know if we should have a more comprehension plan or just stick to where the complaints are on Townhall Rd. Brady asked the length of the drain. Christian stated its 6 to 8 miles. Brady stated that there probably enough to try to scope something that will stay within the \$30,000.00 to \$40,000.00 worth of maintenance. Brady stated he didn't know what ACO is for Gladwin. Luke stated that Gladwin isn't allowed to do anything. We must get approval for any work to be done on the drains. Brady asked if the drain is a roadside ditch on Townhall Rd. Part of it is. It has been rerouted around a campground. Carl Parks suggests that we just get the beavers trapped and dams torn down for right now. He thinks the water will route itself. Christian talked about other areas that had problems. Brady asked if it makes sense to have Spice Group to put together a maintenance plan that would be suited able submission to EGLE for review of the board? Christian asked just along Townhall Rd? Brandy thinks we do the whole thing, and we try to scope something to stay within our maintenance allowance. We will reconvene when we meet for Howe IC and go through both of them.
