 - Notary, CPL, Marriage License and DBA Applications are all available online.
 - As well as the opption to request expidited Vital Records from our office through Official Records Online (ORO)
- * Collected \$9,649 in Reimbursements to the county for election expenses.
- * Processed 421 Set Aside cases from April to December, resulting from Clean Slate Initiative.
 - -279 Successfully set aside by MSP
 - 60 set aside by court staff
 - -82 to be manually pulled and set aside by hand.
 - processing daily reports from MSP for set asides going forward. E37
- * Created and implamented a Bond Tracking process for defendents who have not yet been sentenced to assist the courts with complinace monitoring.

So far in 2024:

- * Completed the KoFile Historic Record Preservation Project
- * Implemented Nine Days of Early Voting
- * Applied for \$34,963 in elections reimbursemnts from the State as of 04/01/2024
- * Clerk Hulme serves as the Chair to District 3 of the Michigan Association of County Clerks (MACC), and sits on MACC's Legislative, Vital Records, and Courts Committees.
- * Extreme Risk PPOs took effect February 2024
 - This was an addition of 8 more forms, multiple process's, and seven more days of processing time for each case.
- * Looking for software/vendor to assist in collections efforts. When the State made the transition to TCS from JIS, we lost the ability to send payment reminders to our defendants. We also temporarily lost the ability to run an accurate, efficient list of defendants for Show Cause Hearings. The impact of that is evident in our restitution and court cost statistics. I reached out to TCS and through a ten month process we are finally able to get show cause back on track. We are still lacking the ability to send payment reminders to Defendants, though.

Expected by 2025

- * Jury Reform various changes proposed including changing a 2-step process to a one step process, tracking statistical information, and submitting annual reports to the State.
