RESOLUTION TO APPROVE BALLOT PROPOSAL
PUBLIC SAFETY PROTECTION RENEWAL
2024 NOVEMBER ELECTION

I. Statements in Support of Resolution

THE CITY COUNCIL OF THE CITY OF GLADWIN, COUNTY OF GLADWIN, STATE OF MICHIGAN, STATES:

WHEREAS the City Council of the City of Gladwin does agree to place a millage proposal renewal on the ballot for the citizens of the City of Gladwin to vote on whether or not they would be in favor of levying a millage to provide certain funding for the Gladwin City Public Safety Department a authorized by law; and

WHEREAS the City Council of the City of Gladwin does agree to request a renewal millage of 2 mills, for five (5) years, to be collected annually in 2025 through 2029, inclusive, to provide certain funding to be used for the purposes of providing public safety services as authorized by law: and

WHEREAS, the City Council of the City of Gladwin has agreed to request that the Gladwin County Election Commission approve the millage proposal being placed on the ballot for the 2024 Election to be held on November 5, 2024.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF GLADWIN, COUNTY OF GLADWIN, HEREBY RESOLVES AS FOLLOWS:

RESOLVED, that the Public Safety Protection Proposal, the language for which is attached hereto, be placed on the Election ballot to be voted upon by the electors in the City of Gladwin on Tuesday November 5, 2024; and it was further,

RESOLVED, that a copy of this Resolution and Ballot Proposal be submitted to the Gladwin County Clerk for placement on the ballot; and it was further,

RESOLVED, that the clerk of the City of Gladwin shall perform any and all things or matters as may be necessary or appropriate under the law to place the above proposition on the ballot as specified.





PUBLIC SAFETY PROTECTION RENEWAL PROPOSAL

In order to continue to provide public safety services to the citizens of the City of Gladwin, shall the City of Gladwin, Gladwin County levy a total of two mills (\$2.00 per \$1000.00) on taxable value of property located in the City of Gladwin for a period of five (5) years beginning with the 2025 tax year and running through 2029 tax levy year (inclusive), which will raise in the first year of such levy an estimated revenue of \$161,696.63 to be used for the purposes of providing public safety services as authorized by law. This levy would be collected on the winter tax bill of 2025 collected on the winter tax bill thereafter. A portion of these revenues will be captured by the DDA.
