The Gladwin County Board of Commissioners met for a regular Board Meeting on September 24, 2024. The meeting was called to order at 9:00 a.m. by Chairperson Karen Moore. The Pledge of Allegiance was said, all commissioners were present.

- Nancy Bodner shared details of the work being done on city streets, and they held a ribbon cutting ceremony for the new cabins at city park

The Board Reviewed the Consent Agenda

The Board reviewed the consent agenda. An addition of RFP reviews for Civil Council was added to New Business, EDC Update under Miscellaneous is moved to 9:15 to be presented virtually. A motion was made by Commissioner Visnaw to approve the agenda as amended, seconded by Commissioner Taylor. All in favor, motion carried.

Approval of the Board Minutes

1. September 10, 2024, Regular Board Meeting

Cash balances were read by Commissioner Taylor. The General Fund balance is \$930,007.47 before the payment of bills.

Department Head Reports

1. Drains Update

Drain Commissioner Walters and Deputy Drain Commissioner Zeestraten, shared information on the status of county drains including projects, beaver damage, and conversations with EGLE.

Miscellaneous

1. EDC Update

Scott Govitz joined the meeting via Zoom. He shared information on the county's status with Middle Michigan Development Corporation (MMDC); with the resignation of the EDC Director, Matt Lang, the EDC is making a recommendation to return to the former model as the Gladwin County EDC. A motion was made by Commissioner Taylor to terminate the MMDC agreement at the end of 2024 and return to the Gladwin County EDC, seconded by Commissioner O'Donnell. All in favor, motion carried.

Finance

- 1. FY 24-25 Budget**
A motion was made by Commissioner Visnaw, seconded by Commissioner Taylor to approve the FY 24/25 Budget as presented. All in favor, motion carried.
- 2. Program Income Annual Report**
Treasurer VanTiem gave an update on the Program Income Certificate. She reported for July 1, 2023 thru June 30th, 2024, we received \$9545 in funding that the State will allow us to keep. These funds will be added to the program income fund.
- 3. Request approval to allow additional funding from CDBG**
Treasurer VanTiem and PCD Consultant, Kimberly Hines, shared details of their request. A resident is in need of additional funding for well issues. They are asking the board to approve another \$2000, to drill further, the total funds allowed would still be less than the \$10,000 limit for the program, A motion was made by Commissioner Taylor to authorize an additional \$2000. Any additional funding to come from another entity. Seconded by Commissioner Visnaw. Additional conversation was had. Roll call vote, 2-y, 3-n, motion defeated.
- 4. Foreclosing Governmental Unit (FGU) Annual Report**
Treasurer VanTiem reported tax year 2022. All but two parcels of the original thirty-three have been sold. Sales totaled \$267,000, of which \$86,000 is being held for pending lawsuits. A motion was made by Commissioner O'Donnell to accept the FGU Annual Report, seconded by Commissioner Taylor. All in favor, motion carried.
- 5. Request approval to Enroll in Lexipol's Online Training Program**
Undersheriff Hartwell shared details of his request for an online training that will be covered by the State, no general fund dollars would be used. A motion was made by Commissioner Taylor to approve \$2,205 for the Undersheriff to attend the Lexipol's Online Training Program; funds to come from the 302-CPE fund. The motion was seconded by Commissioner Visnaw. All in favor, motion carried.

New Business

- 1. Jail Inmate Contract with Ogemaw**
Undersheriff Hartwell and Jail Administrator, Matt McGourty, shared details of the proposed contract. A motion was made by Commissioner Taylor to allow the Chair to sign the contract with Ogemaw County for housing their inmates, pending Ogemaw's approval on Thursday. The motion was seconded by Commissioner Grove. All in favor, motion carried.

Return to Finance

- 6. Lake Drain Committee Payments Returned to 1099's**
Deputy Drain Commissioner Lucy Zeestraten, shared details of her request. A motion was made by Commissioner O'Donnell to allow Drain Committees to be paid from Accounts Payable, effective with the 24/25 budget. The motion was seconded by Commissioner Moore. Roll call vote, 4-y, 1-n, motion carried.

Civil Attorney Report


- Solar Application for Grout township materials have come in.
